Representative Matters

Fraud & White-Collar Defense

- **No Convictions for Real Estate Agent in Federal Felony Fraud Trial**

Successfully defended a real estate agent facing extensive jail time during a federal trial in the District of New Jersey against felony charges of conspiracy to commit wire fraud, conspiracy to commit money laundering, and aiding in the submission of a false statement to a bank. After a five-week trial in federal court, there were no convictions. Client was acquitted of one count and had no convictions on the remaining two counts. Ultimately, the client received a single misdemeanor and no jail time.

- **Represented Surgeon at Trial in a Federal Conspiracy Case**

Represented at trial a surgeon charged in a federal health care fraud case with conspiracy, illegal kickbacks, and money laundering in the Northern District of Texas in a complicated multi-defendant case.

- **Felony Welfare Fraud Case Dismissed at Arraignment**

Felony welfare fraud case dismissed at arraignment in Los Angeles County after the firm contacted the prosecutor before the arraignment and showed proof of incorrect calculations.

- **Doctor Facing Kickback Allegations Receives Reduced Sentence**

Represented a doctor in San Diego County originally facing substantial prison time for multiple allegations regarding kickbacks and Labor Code violations. Obtained a lesser sentence on a plea to far fewer charges and minimal jail time.

Sexual Misconduct Allegations

- **College Student Avoids Charges in Sexual Assault Case**

Represented a student accused of sexual assault by a fellow student. The college found no basis for the claims and no criminal charges were filed.

- **Sexual Battery Charge Reduced for Financial Analyst**

Negotiated a plea to simple battery and summary probation for a financial analyst accused of sexual battery, avoiding sex offender registry conditions.

- **No Charges Filed Against Government Contractor**

No charges filed after representing a government contractor under investigation for child sexual assault.

- **Preliminary Hearing Representation for Actor Client**

Represented actor charged with multiple counts of rape and special allegations through the preliminary hearing stage in Los Angeles County.

Criminal Defense

Case Dismissed when Victim Wrongly Charged with Domestic Violence

Case dismissed by prosecutors on the eve of trial after firm's independent investigation in a case where the actual victim had been charged with domestic violence and assault with a deadly weapon in Los Angeles County.

- **Contractor Cleared of Violent Assault Charges with Self-Defense Claim**

Case dismissed by prosecutors against a contractor in New York County after the firm's investigation and presentation of a viable self-defense claim.

- **Case Dismissed Against Wrongly Accused Client**

Successfully defended and proved client had been falsely accused of child sexual abuse in the midst of a divorce dispute.

- **Police Officer Cleared in Child Abuse Investigation**

Represented a police officer in San Diego County falsely accused of child abuse investigation. After conducting an independent investigation and consulting experts, no charges were filed.

- **Attempted Murder Conviction Overturned on Appeal in Los Angeles**

Defended client at trial in Los Angeles charged with two counts of attempted murder, shooting at an occupied vehicle, fleeing the scene, and gang enhancements. Jury convicted, but the case was overturned on appeal due to error made by the Judge which our firm had pointed out and preserved at the time.

- **Public Figure Represented in High-Profile Murder Case**

Represented public figure in Los Angeles County charged with murder, attempted murder, and felony hit and run resulting in death.
